THE TREASURER AND AUDITOR NOTED THAT THEY WERE ADVANCING FUNDS MONTHLY.






SHERIFF COMMISSARY REPORT:




A MOTION TO ADJOURN WAS MADE BY CARMONY, SECOND SMITH, VOTE 7-0.
