THE SHELBY COUNTY COMMISSIONERS MET AT 1:00 P.M. ON TUESDAY JANUARY 2, 2007. PRESENT WERE COUNCIL MEMBERS LAIRD, MOHR, NEWTON, AND THE DEPUTY AUDITOR.

MINUTES:

A MOTION TO APPROVE THE MINUTES FOR DECEMBER 11, DECEMBER 15, AND DECEMBER 18 WAS MADE BY LAIRD, SECOND BY NEWTON AND APPROVED 2-0-1 (MOHR ABSTAINED).

APPOINTMENTS WERE SET:

A MOTION TO APPOINT NEWTON FOR PRESIDENT AND MOHR AS VICE PRESIDENT WAS MADE BY LAIRD AND SECOND BY NEWTON, APPROVED 3-0, OTHER APPOINTMENTS WERE MADE (SEE ATTACHED LIST) APPROVED BY LAIRD SECOND BY MOHR 3-0

SHELBY COUNTY SUPERIOR II:

JUDGE SANDERS PROPOSAL TO BRING THE SPONSORED DRUG AND ALCOHOL PROGRAM FROM A CONTRACT BASIS TO AN IN HOUSE PROGRAM, SAVING THE COUNTY AND BEING ABLE TO KEEP BETTER TRACK OF THE PROGRAM. FUNDS WILL COME FROM USERS FEES. THEY WILL BE HIRING ONE PERSON AND USING AN OFFICE IN THE COURT HOUSE. THEY WANT TO USE THE BALANCE IN THE 410 ACCOUNT AROUND \$30,000 FOR START UP COST. AMENDMENT 2 PRESENTED EFFECTIVE JANUARY 1, 2007. AMENDMENT STATES THAT ONLY EMPLOYEES WORKING 30 HOURS A WEEK WILL BE ELIGIBLE FOR COUNTY BENEFIT PLAN. PART-TIME, TEMP/SEASONAL EMPLOYEES, COUNTY COMMISSIONERS, COUNTY COUNCIL AND COUNTY TRUSTEES WILL NO LONGER BE ELIGIBLE. MOTION MADE BY LAIRD SECOND BY MOHR APPROVED 3-0


CLAIMS:


A LIST OF CLAIMS WERE PRESENTED TO THE COMMISSIONERS AND APPROVED.

APPROVED 3-0


