

THE SHELBY COUNTY COUNCIL MET ON TUESDAY JUNE 19, 2007 AT 7:00 P.M. PRESENT WERE COUNCIL MEMBERS SMITH, FUCHS, CARMONY, DEBAUN, SANDERS, GRUBBS, BRUNK AND THE AUDITOR.

MINUTES:

MOTION WAS MADE TO APPROVE THE MINUTES FROM MAY 15, 2007 BY CARMONY SECOND BY DEBAUN APPROVED 6-0. (GRUBBS IN LATE)

SENATOR JACKMAN:

SENATOR JACKMAN AND REPRESENTATIVE CHERRY WERE PRESENT TO DISCUSS HOUSE BILL 1478. THIS IN REGARDS TO THE PROPERTY TAX RELIEF. HOWEVER THESE ARE JUST SHORT TERM RELIEF. WITH HOUSE BILL 1478 THIS GIVE THE LOCAL GOVERNMENT TOOLS TO CONTROL THE PROPERTY TAXES. LOCAL OPTION INCOME TAX (LOIT) THREE PARTS TO THIS BILL GIVE YOU 3 OPTIONS. PART A YOU PASS A LOIT THAT TAKES CARE OF THE INCREMENTAL INCREASE COST TO THE LOCAL GOVERNMENT (RAISES, SALARIES, LEVY) IN SHELBY COUNTY THAT IS .2% IN THE FIRST YEAR AND .1% THE NEXT YEAR AND ½ OF THE FIRST YEARS MONIES HAS TO GO IN THE RAINY DAY FUND JUST IN CASE OF SHORT FALL IN FOLLOWING YEARS. PART B YOU CAN ADOPT UP TO A 1% INCOME TAX IN ADDITION TO THE .2%. YOU CAN START WITH .25% AND INCREASE IN .500 % INCREMENTS UP TO THE 1%. THIS WOULD BE TOTALLY DEDICATED TO PROPERTY RELIEF ONLY. THIS CAN GO FOR HOMESTEAD ONLY OR YOU CAN BREAK IT DOWN BETWEEN AG, RESIDENTIAL, ETC. . PART C- WOULD BE A NEW TAX FOR PUBLIC SAFETY. YOU CAN INCREASE UP TO .25% FOR PUBLIC SAFETY ONLY. IF YOU DO PART C YOU MUST ADOPT PART A & B. ADOPTING PERIOD IS BETWEEN MARCH 1 AND JULY 31ST. IF ADOPTED YOU MAY START COLLECTING IN OCTOBER AND DISTRIBUTED IN JANUARY AND WOULD BE JUST LIKE CAGIT.




