

THE SHELBY COUNTY COMMISSIONERS MET ON MONDAY JUNE 29, 2020, AT 8:00 A.M. PRESENT WERE COMMISSIONERS NIGH, ROSS, PARKER, COUNTY ATTORNEY AND COUNTY AUDITOR

MINUTES:

MOTION TO APPROVE JUNE 22, 2020 MINUTES WAS MADE BY PARKER SECOND BY ROSS, APPROVED 3-0

KYLE PRUITT/ALL VACATION WALDRON COLUMBIA ST.:

KYLE IS REQUESTING TO VACATE THE ALLEY BETWEEN LOTS 27 & 28 LOCATED IN MAPLE'S ADDITION IN THE CITY OF WALDRON, SHELBY COUNTY, INDIANA. PRUITT ADVISED ALL NOTICES WERE SENT OUT AND THE CERTIFICATION CARDS HAVE BEEN TURNED INTO THE COMMISSIONERS OFFICE. MOTION TO APPROVE THE PETITION TO VACATE PUBLIC WAYS OR PLACES WAS MADE BY PARKER, SECONDED BY ROSS, APPROVED 3-0

SHERIFF:

SHERIFF ADVISED IN ORDER TO KEEP MOVING ON THE PSAP INTERLOCAL AGREEMENT THE COMMISSIONERS WILL NEED TO APPOINT INDIVIDUALS TO THE OPERATIONS BOARD. THEY WILL INCLUDE A TOWN MARSHALL AND A VOL. FIREMAN. KOCH ADVISED THERE IS ONLY TWO TOWN MARSHALLS TO CHOOSE FROM AND EITHER ONE WOULD BE GOOD. KOCH ADVISED THAT HENRY ALBRECHT HAS BEEN AN OFFICER, JAIL OFFICER, DISPATCHER. KOCH ALSO ADVISED HE SPOKE WITH ARRON LATHROP WHO IS THE PRESIDENT OF THE COUNTY VOLUNTEER ASSOCIATION WILL BE COMING BEFORE THE COMMISSIONERS NEXT WEEK TO GIVE A RECOMMENDATION FOR THE BOARD. KOCH ADVISED THEY FIRST TALKED ABOUT THIS PERSON IS NOT TO BE AN EMPLOYEE OF THE SHELBYVILLE FIRE DEPT, BUT LATHROP ADVISED THAT 7 OF THE 9 FIRE CHIEFS ARE EMPLOYEES OF THE SHELBYVILLE FIRE DEPARTMENTS AND YOU WANT SOMEONE ON THE BOARD THAT IS GOING TO BE ACTIVE AND KNOW WHAT WE NEED. MOTION TO APPROVE HENRY ALBRECHT AS THE TOWN MARSHALL FOR THE OPERATIONS BOARD WITH JOSH KUNTZ AS BACKUP WAS MADE BY ROSS, SECONDED BY PARKER, APPROVED 3-0

KOCH ADVISED THAT THE INSURANCE COMPANY IS REQUESTING THAT ALL FIRE SPRINKLERS HAVE A COMPLETE INSPECTION DONE ON THEM. KOCH THOUGHT THIS SHOULD BE A COMMISSIONER DECISION. KOCH ALSO ADVISED HE HAD SPOKEN WITH HIS MAINTENANCE PERSON AND HE ADVISED THEY HAVE HAD INSPECTIONS, THAT MIGHT WORK FOR THE INSURANCE COMPANY AND KOCH WILL FORWARD THEM TO BRADY CLAXTON AS SOON AS HE GETS THEM FROM HIS MAINTENANCE MAN.
