**MINUTES:**

MOTION TO APPROVE WITH MARCH 8, 2021 MINUTES WAS MADE BY ROSS, SECONDED BY NIGH, APPROVED 2-0-1 (PARKER)

**PUBLIC HEARING PLEASANT VIEW BOT**

AT THIS TIME COMMISSIONER NIGH OPENED THE MEETING FOR PUBLIC COMMENT. NO PUBLIC COMMENT WAS MADE, MOTION TO CLOSE PUBLIC HEARING WAS MADE BY ROSS, SECONDED BY PARKER, APPROVED 3-0

AT THIS TIME COMMISSIONER NIGH READ A LETTER CONCERNING THE PROJECT AND PRESENTED RESOLUTION 2021-8 AWARDDING THE BOT. MOTION TO APPROVE RESOLUTION 2021-8 WAS MADE BY ROSS, SECONDED BY PARKER, APPROVED 3-0

MOTION TO TABLE UNTIL NEXT WEEK WAS MADE BY ROSS, SECONDED BY PARKER, APPROVED 3-0

**CHANDRA MILL / ABM INDUSTRY CONTRACT:**

THE COMMISSIONERS PRESENTED THE JANITORIAL SERVICE CONTRACT WITH ABM INDUSTRY GROUPS. THIS WILL BE A 12 MONTH AGREEMENT. THEY COMPANY WILL INTERVIEW TOM AND BRENDA; THE COST WILL BE \$17,649.74 A MONTH. THEY WILL HAVE SOMEONE ON HAND 5 DAYS A WEEK EQUALING 12 HOURS A DAY. AT THIS POINT THERE WERE SOME COMMENTS MADE BY ELECTED OFFICIALS. RECORDER – HAD SECURITY CONCERNS AND PRIVATE THINGS THAT CAN'T BE LOCKED UP BECAUSE THEY ARE BIG BOOKS. SHE ALSO STATED THE TOM IS A 31 YEAR EMPLOYEE AND CAN'T BELIEVE THEY ARE JUST GOING TO GET RID OF HIM. AT THIS TIME TAWNYA WAS ASKED TO SIT DOWN AND IF TOM WANTED TO SPEAK, HE COULD. TOM MORSE SPOKE AT THIS TIME AND SAID HE HAS BEEN DOING FRANKS JOB FOR 7 MONTHS WITHOUT COMPENSATION AND DOESN'T WANT TO CONTINUE TO DO THIS JOB AND IS EXCITED TO MOVE ON NO MATTER WHAT THEY DO. COUNTY AUDITOR GLACKMAN SPOKE ABOUT SECURITY CONCERNS AND DOESN'T WANT PEOPLE IN HER OFFICE AFTER OURS, SHE ALSO ADVISED THEY WILL HAVE A MASTER KEY SO YOU CAN'T JUST SHUT THE DOOR. ROSS ADVISED THAT WE WILL JUST HAVE TO LOCK THINGS UP EVERY NIGHT THAT HAS PERSONAL INFORMATION ON IT. HE ALSO ADVISED THIS IS THEIR BUILDING AND THEY WILL DECIDE WHEN THINGS GET DONE. COMMISSIONER PARKER SHARED THEY KNEW FRANK WAS GOING TO RETIRE SOMETIME AND HAVE ALWAYS TALKED ABOUT WHAT THEY WOULD DO THEY STUDIED THING AND FEEL THIS IS THE BEST WAY TO GO FOR THE COUNTY. PROSECUTOR BRAD LANDWERLEN HAD 2 CONCERNS THE FIRST IS SECURITY CONCERNS, BRAD EXPLAINED ANYONE GOING INTO THE CHILD SUPPORT AREA HAS TO HAVE SPECIAL TRAINING JUST LIKE TOM AND BRENDA HAVE HAD TO HAVE. ANOTHER CONCERN IS YOU SAY LOCK THINGS UP AT NIGHT, WELL IF WE ARE WORKING ON A CASE AND HAVE THINGS SPREAD

OUT IT ISN'T THAT EASY. CHANDRA ADVISED THEY CAN DO SPECIAL TRAINING FOR THE PEOPLE THAT WILL BE IN THERE. BRAD HAD ANOTHER CONCERN ABOUT THE FACT THEY WOULD HAVE A MASTER KEY AND BE ABLE TO GAIN ACCESS TO ALL ROOMS. THE PROSECUTOR ADVISED THEY HAD AN EVIDENCE ROOM WITH DRUGS, WEAPONS AND OTHER STUFF IN THAT THEY CAN HAVE PEOPLE GOING IN THERE. ROSS ASKED IF HE WAS SURE THAT FRANK, TOM OR BRENDA HAD NEVER BEEN IN THERE, LANDWERLEN ADVISED NO BUT THERE IS A TRUST BUILT THERE. ROSS SAID THERE WOULD BE NO MASTER KEYS HANDED OUT BY US AND THAT IS IN THE CONTRACT. LANDWERLEN ASKED IF THEY HIRE FELONS, CHANDRA ADVISED NO, BUT WHEN LANDWERLEN ADVISED IS SAYS ON YOUR WEBSITE YES, THEY DO HIRE FELONS, CHANDRA ADVISED THEY HAVE A SECOND CHANCE PROGRAM FOR PEOPLE, LANDWERLEN ASKED AGAIN DO YOU HIRE FELONS AND CHANDRA ADVISED NO, LANDWERLEN THEN ADVISED YOU JUST SAID YOU HAVE A SECOND CHANCE PROGRAM, CHANDRA ADVISED THOSE PEOPLE DON'T WORK IN OFFICES. CHANDRA ADVISED THEY CAN DO THE CLEANING IN THE DAYTIME IF THAT IS WHAT WE WANT, THEY WILL WORK WITH US. LANDWERLEN ALSO HAS CONCERNS THAT THE COUNTY IS JUST GOING TO LET A 31 YEAR EMPLOYEE GO. YOU SAY YOU WILL INTERVIEW THEM, BUT THAT DOESN'T SAY YOU ARE GOING TO HIRE THEM. KYLE BARLOW WANTED TO MENTION MAYBE SOMEONE FROM THE COUNTY COULD SIT IN ON THE INTERVIEW. MOTION TO APPROVE THE CONTRACT WAS MADE BY PARKER, SECONDED BY ROSS, APPROVED 3-0
